WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

The proposed 2026 Annual Budget calls for appropriations of \$2,437,734.03. Appropriations for the 2025 Adopted Annual Budget were \$2,305,153.20. This is an increase of \$137,772.23 or 5.8%. The reason for the increase is due to the District anticipating increase costs for all insurances and several salaries.

3. **Explain any variances over +/-10% for each line item.** Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item. **Be sure to include ALL items for F-2, F-3, and the detail sheets.**

Unrestricted Fund Balance has decreased to \$31,406.28 in the proposed 2026 Annual Budget. This is a decrease of \$73,475.98 or 70.1%. The 2025 Annual Budget included a Deferred Charge of \$75,000. Investment Account #1-Operating Bank Account has increased to \$24,000 in the proposed 2026 Annual Budget. This is an increase of \$23,500 or 4,700.0%. Investment Account #2-Payroll Bank Account has decreased to \$120 in the proposed 2026 Annual Budget. This is a decrease of \$80 or 40.0%. Investment Account #3-Certificate of Deposit has decreased to \$300 in the proposed 2026 Annual Budget. This is a decrease of \$300 or 50.0%. The District's existing bank was purchased by another bank and thus the associated interest rates on the existing bank accounts have changed. Fringe Benefits Administration-Personnel has increased to \$83,129 in the proposed 2026 Annual Budget. This is an increase of \$9,885 or 13.5%. The District is expecting increases in all insurances. Salaries & Wages-Cost of Operations & Maintenance-Personnel has increased to \$710,315.76 in the proposed 2026 Annual Budget. This is an increase of \$75,922.76 or 27.5%. The anticipated increases are due to normal annual increases in Fire Fighter salary and a necessary increase in the provision for Alternates and Substitutes. Fringe Benefits-Cost of Operations & Maintenance-Personnel has increased to \$532,876.16 in the proposed 2026 Annual Budget. This is an increase of \$114,772.07 or 27.5%. The District is anticipating significant increases in health insurance costs as well as increases in other insurances. Emergency Appropriation #1-Replacement Utility Vehicle has decreased to \$0 in the proposed 2026 Annual Budget. This is a decrease of \$75,000 or 100.0%. The 2025 Annual Budget included a provision for a replacement utility vehicle, which was a one time purchase in 2025. Total Interest Payments on Debt has decreased to \$2,228.39 in the proposed 2026 Annual Budget. This is a decrease of \$1,768.70 or 44.2%. The District's Capital Lease on their Pierce Ascendant 107' Ladder Truck is coming to an end in 2026 so the associated interest payments are decreasing per the lease agreement amortization schedule. Election has increased to \$7,500 in the proposed 2026 Annual Budget. This is an increase of \$2,500 or 50.0%. The District has experienced an increase in mail in ballots and the associated printing cost of those ballots has increased. Advertising has increased to \$2,000 in the proposed 2026 Annual Budget. This is an increase of \$1,000 or 100.0%. The provider has increased their costs on budget and personnel advertising.

The District is going to utilize the maximum allowable amount to be raised by taxation for the 2026 Budget. The District is also electing to qualify the increase in pension and health care costs for the 2% cap exclusion. These items will be increasing the amount to be raised by taxation without violating the 2% cap.
