Regular Meeting Minutes

October 2, 2018

- I.** The meeting of the Board of Fire Commissioners was called to order by Chairman Engelbert at 7:00pm with the Pledge of Allegiance to the flag.
Roll Call: Present: Commissioner DeRosa, Commissioner Rinaldi, Commissioner Moran, Chairman Engelbert, Solicitor Carlamere
Absent: Commissioner Lloyd
- II. Treasurer's Report-** Commissioner DeRosa submitted bills for the month of October in the amount of \$36,692.84. Motion to approve was made by Commissioner DeRosa; seconded by Commissioner Rinaldi.
Roll Call: 4-0 Motion Carried.
- III Minutes-** Motion to approve the minutes for the month of September was made by Commissioner Rinaldi; seconded by Commissioner Moran.
Roll Call: 4-0 Motion Carried
- IV. Clerk's Report-** Kay Harmon stated that all is well and there is nothing to report.
- V. Career Report-** Commissioner Moran speaking for Deputy Fire Marshal Steve Schwegel said that a thermal imaging camera (TIC) is needed.
The cost will be \$7,640.58. Also, equipment, including brackets, is needed in order to put the old Quint in service at a cost of \$3,982.00. Chairman Engelbert stated that three more quotes are necessary
At this time, Commissioner Rinaldi made a motion to swear in Nick Angelozzi as a paid firefighter; seconded by Commissioner Moran. Roll Call- 4-0 Motion carried.
Firefighter Angelozzi was sworn in by Solicitor Carlamere followed by a round of applause and congratulations. A motion was made by Commissioner Moran to approve the Memorandum of Agreement; seconded by Commissioner Rinaldi.
- VI. Fire Marshal's Report- (attached)** Fire Marshal Rich Donato thanked all who took part in the Fire Prevention event at the outlets.
- VII. Chief's Report-** Chief Goins stated that he heard rumors that truck 51 had been sold. He questioned the validity of the rumors. Also, the chief questioned when the computer will be working. AT&T had been called a few times, but no one has received a return call. Chairman Engelbert stated that he was promised that the problem will be resolved the next day, Wednesday, October 3.
- VIII. President's Report-** President Loftus congratulated Nick Angelozzi on being sworn in. He also congratulated Fire Marshal Rich Donato for doing a good job

on the Fire Prevention event. He then reported that the chairs for upstairs had been purchased.

IX. Commissioners' Report-

Commissioner John Moran reminded the firefighters to go over truck 852 for scratches and dings.

Commissioner Rinaldi also expressed congratulations on a job well done on the good turnout at the Fire Prevention event.

Chairman Engelbert stated the need for crews for Saturdays now that Nick Angelozzi has been sworn in. He said that we now have a driver and we need to have duty crews lined up for Saturdays.
