- **II. Treasurer's Report-** Commissioner DeRosa submitted bills for the month of December in the amount of \$47,663.34. Motion to approve was made by Commissioner DeRosa; seconded by Commissioner Rinaldi. Roll Call: 5-0 Motion Carried.

- IV. Clerk's Report- Clerk Kay Harmon thanked Chief Goins for fixing the heater. She, Clerk Alice LaMalfa and Recording Secretary Janet Tulino wished everyone a Merry Christmas and a Happy New Year.
- V. Career Report- Chief Goins reported that the mechanic ordered the part needed for 54.
- **VI. Fire Marshal's Report- (attached)** Clerk Kay Harmon reported that Fire Marshal Rich Donato will be out due to hand surgery until December11th
- VII. Chief's Report- Chief Goins requested that career members attend a ceremony welcoming 120 deployed military personnel. It was decided that there will be department members in attendance. Also, the chief stated that he needs to order a box and radio for the back of the new car. Chairman Engelbert told the chief to place the order. The bill will be paid in 2020 from the January budget. Chief Goins also stated that there is an odor once again in the engine bay. Clerk Harmon reported that the odor is also in the ladies restroom. Chairman Engelbert made recommendations to alleviate the problem.
- **VIII. President's Report-** President Loftus announced that Santa will be arriving in the district at 11:30am on December 11. He will try to be on two sides of the district. As this was his last meeting as President, President Loftus once again
