2<sup>nd</sup>. The Board of Fire Commissioners then set a time and place for the holding of a public

hearing on the budget, was published at least 10 days prior to the said hearing.

3<sup>rd</sup>. The public hearing and second reading of the budget was held not less than 28 days after the first reading and approval, and the budget was adopted at the second reading, all of which was not later than 25 days prior to the annual election.

4<sup>th</sup>. The adopted Budget is authorized to be advertised by publishing at least once in a newspaper

at least 7 days prior to the annual election.

5<sup>th</sup>. This resolution is adopted in compliance with N.J.S.A. 40A: 14-78.2 et al.

- 3<sup>rd</sup>. The public hearing and second reading of the budget was adopted at the second reading, all of which was not later than 25 days prior to the annual election.
- 4<sup>th</sup>. The adopted budget is authorized to be advertised by publishing at least once in a newspaper at least 7 days prior to the annual election.
  - 5<sup>th</sup>. This resolution is adopted in compliance with N.J.S.A. 40:14-78.2 et al.
