Regular Meeting Minutes October 2, 2022

I. Call to Order

The meeting of the Board of Fire Commissioners was called to order at 7:00 p.m. Chairman Engelbert delivered the Sunshine Notice and led the Pledge of Allegiance.

- **VII. Fire Marshal Report** Attached. Captain Donato thanked everyone for all the help with the Fire Prevention Day and stated that the Smoke House Trailer was donated by the Cherry Hill Fire Department.
- VIII. Chief's Report Chief Goins reported that he received another quote for a gear washer but the quote was more than the last one that he received. Chief Goins presented a list of schools that some of the fire fighters would like to attend. A smoke machine quote was presented and approved to order as well as an order for radios and lights for the squad which were also approved to be ordered. We have a new volunteer by the name of Joe Kelly with experience from the Glendora Fire Company

- XIII. Chief Goins presented Fire Fighter Ed Fowler a new Fire Helmet since he has now been here for 4 months.
