Regular Meeting Minutes

May 6, 2025

- I. **Call to Order:** The meeting of the Board of Fire Commissioners was called to order at 7:00 p.m. Chairman Engelbert delivered the Sunshine Notice and led the Pledge of Allegiance.

- III. **Treasurer's Report** – Commissioner Rinaldi read the Treasurer's report and the submission of bills for the month of **May 2025** in the amount of **\$100,495.19** as well as a corrected amount for the bills paid for the month of February in the amount of \$83,923.78 to \$80,860.11 due to Check #2059 being voided out to IIA Fire Department Testing in the amount of \$3,083.67 and a correction to the bills from April 2025 from \$59,806.81 to \$59,178.81 due to Check #3375 being voided out to International Association of Arson Investigators, seconded by Commissioner Lloyd

- IV. **Minutes** - A motion to approve the Regular Meeting Minutes for the month of **April 2025** was made by Commissioner Rinaldi, seconded by Commissioner Lloyd

- VI. **Career Report** – Firefighter Kelly stated that he felt that Workmen's Compensation is incompetent due to the fact that his doctor's appointment was rescheduled and that he was going for his next appointment on May 9 per the insurance company
- VII. **Fire Marshall's Report** – None at this time
- VIII. **Chief's Report** – Chief Dimitri presented his April Chief's report to the Board

of Fire Commissioners. There were a total of 72 calls with 3 working fires. The Quint was taken to Bud's repair to have the alignment complete. The aerial test and the pump test was completed and both passed. Chief Dimitri also requested that the SCBA services be switched from Dival to Firefighter One. Chairman Engelbert approved the request.

IX. President's Report – None at this time due to the fact that Firefighter Ottinger was out sick.


X. Commissioner's Report – Commissioner Rinaldi stated that since the weather is starting to get hot, to stay hydrated. Chief Dimitri stated that he will be turning in a hot weather report that is required by the state. Firefighter Fowler stated that we need to buy tires and that the Gloucester Township Public Works will install them for us. Chairman Engelbert approved the request. Commissioner Sprinitis asked if we were responding to calls on the Expressway. Chief Dimitri stated that we are waiting for approval from the Safer Board. When the approval does come through, the Expressway will reimburse us which may take place in a couple of months.

XII. Adjournment – Chairman Engelbert asked for a motion to adjourn. A motion was made by Commissioner Rinaldi, seconded by Commissioner Davidson. All in favor. Motion carried. The meeting was adjourned at 7:11 p.m.
