Regular Meeting Minutes

September 2, 2025

I. Call to Order: The meeting of the Board of Fire Commissioners was called to order at 7:00 p.m. Chairman Engelbert delivered the Sunshine Notice and led the Pledge of Allegiance.

After Roll Call, there was a swearing in for Nicholas Angelozzi as Captain of The Gloucester Township Fire District #5 by Mayor David Mayer and Nicholas Spross as Fire Chief of the Lambs Terrace Fire Company with both families of Nicholas Angelozzi and Nicholas Spross in attendance.

Mayor Mayer thanked all of the firefighters for all that they do for the residents of Gloucester Township Fire District #5 and gave special thanks to their families. Everyone congratulated both Nicholas Angelozzi and Nicholas Spross on their promotions. Assemblyman Cody Miller and Dan Hutchinson were also in attendance and both congratulated and thanked the firefighters for all that they do for the district.

III. Treasurer's Report – Commissioner Rinaldi read the Treasurer's report and the submission of the bills for the month of **September 2025** in the amount of \$84,749.54; motion to approve the Treasurers Report was seconded by Daryl Lloyd

Roll Call: 5-0 Motion carried


V. Clerk's Report – None at this time

- VI. Career Report** – Firefighter Ed Fowler stated that the tires have been ordered and we are trying to have the tires scheduled to be installed for Thursday. Fire Fighter Ed Fowler asked Clerk Cindy Jeminey if she has received the bill from Bud's for the repairs for the fire truck. Chairman Engelbert stated that we have received the bill but are waiting to pay the bill since the truck is still not fixed. Also, Firefighter Ed Fowler stated that he is trying to get the quote for the lights from Pierce
- VII. Fire Marshall's Report** – None at this time since Fire Marshall Schwegel was absent
- VIII. Chief's Report** – There were a total of 73 calls for the month of August and a total of 653 calls for the year. Squad 85 is still O.O.S. The part for the Interlock Module has been ordered but is on back order. The Quint 85 tires have been ordered and are waiting for Public Works to set up a date to have them do the job. (6) SCBA bottles went out for Hydro testing and were returned to service. (4) SCBA bottles have passed their in service date and have been removed from service. We received applications for 3 new members but they still need to be voted in. Chief Spross also congratulated Captain Angelozzi on his promotion and stated that he has done a great job leading the A-Platoon and will continue to do great things moving forward. Chief Spross stated that he has met with Winslow Township Chief Rigberg as an introductory meeting and he looks forward to continuing to work together on incidents. They would like to see some training between the towns in the future to strengthen our working relationship. Chief Spross has met with Chief Haines from Chews Landing as an introduction formatted meeting and things went well. We had an event with Philadelphia Eagles Rookie Jihaad Campbell at Hickstown Park and the event went well and had a good community turnout. We are looking into a cost recovery program for MVA's and more information will be provided once he speaks with the rep from the company. We have put out a post on social media for open fill in positions and have received about 12 resumes so far. Interviews will be set up after the deadline is over. We also have our annual burn scheduled for October 11, 2025 at Camden County from 0800-1200 hours.

- X. Commissioner's Report** – Commissioners Rinaldi, Sprinitis, Davidson and Lloyd and Chairman Engelbert all congratulated both Nicholas Angelozzi and Nicholas Spross on their promotions. Chairman Engelbert stated that the tires that he purchased are not Goodyear tires; they are Hancock tires and they are at Public Works. At this time, we only have one truck and will need Pine Hill to cover for us.
